WHEREAS:

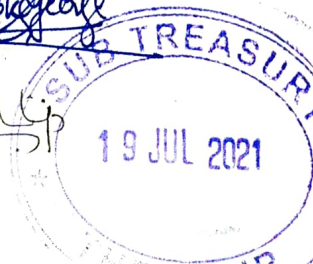

SCOPE OF THE MOU

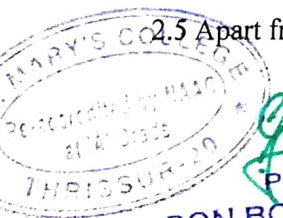


