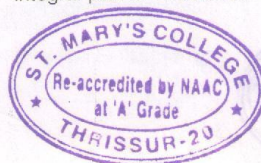
**AND**

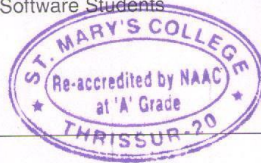
