

MEMORANDUM OF UNDERSTANDING (MOU)

BETWEEN

BRILLIANCE COLLEGE CIVIL SERVICE ACADEMY

AND

ST. MARY'S COLLEGE, THRISSUR

This Memorandum of Understanding (MOU) is a service agreement to provide training to students for competitive exams (Bank/SSC) between Brilliance College Civil Service Academy, Thrissur and St. Mary's College, Thrissur.

The parties operating under this MOU agree as follows:-

A. Purpose: - Brilliance College, the most popular and leading coaching centre in Thrissur has its branches all over Kerala, identify, promote and train the aspirants from school up to graduation with fully dedicated and experienced faculty. Brilliance College conducts In-House training programs in many reputed colleges also.

B. St. Mary's College, the First Grade College for women in the district, affiliated to Calicut University, situated in the heart of Thrissur. It is administrated by C.M.C Education Society. The college is accredited by NAAC in 2010

The parties intend to enter into an MOU to provide training programme for competitive exams (Bank / SSC) to students of St. Mary's College in association with Brilliance College.

C. Responsibilities: - Brilliance College will be responsible to provide the classes for Bank / SSC exams for a total of 55 hrs. The course content and study materials will be issued and regular assessment of the classes will be done

D. St. Mary's College: On its part will be responsible to promote these courses among students and also ensure hosting and pricing of the course, in consultation with Brilliance College.

E. Financial Agreement: - Brilliance College and St. Marys' College agree to collect Rs. 4,500/- (Four thousand five hundred rupees only) from each student who attend the course.

F. The Revenue Sharing Structure:- 10% of the total collected fees will be given to the authorities of St. Mary's College.

G. Term: - The term of this MOU shall be effective from the day of commencement of the course ie, 29/09/18 and will be terminated after the pre-mentioned time of the course duration. The MOU can be renewed for a further period on terms agreed by both the parties, at that time.
